Important FSA ID and FAFSA instructions:

- Follow the online directions carefully to limit delays.
- Enter your social security number and name exactly as it appears on your Social Security Card.
- Enter marital statuses as of the day you fill out the FAFSA.
- High school name should match the name on your high school diploma.
- AGI and taxes paid are never the same amount, be sure to enter accurate amounts.
- Incorrectly filing as head of household: Federal regulations require an amended tax return to be filed with the Internal Revenue Service (IRS) before disbursement of aid is allowed.

Step 3: Complete Loan Entrance Counseling and Master Promissory Note (MPN)

Students borrowing Federal student loans are required to complete Loan Entrance Counseling and Master Promissory online.
